Helping Hand has no other assets or liabilities other than cash at the beginning and at the end of the year. No financing or investing activities were carried out during the year. Hence the cash flow statement has not been presented.

### **Notes to Financial statements**

December 31, 2005

#### **Note -1**

##### **Description and summary of significant operations**

Helping Hand USA, Inc. was incorporated in 1998 in the state of NY. It was, however, not in operation until 2005. Helping Hand started its operations in September 2005 by receiving initial funds from ICNA Relief, a USA registered charity organization that decided to focus on relief projects in USA and to delegate its international charity work to Helping Hand. ICNA donated \$2,276,730 to Helping Hand to implement relief projects, mostly for victims of earthquake in Pakistan.

The main objective of Helping Hand is to provide relief and to help the victims of disasters and others in need by carrying out emergency relief, poverty alleviation and other developmental relief projects by receiving donations from individuals as well as corporations in the United States of America. These projects are implemented directly, or through partner charitable institutions. The partner charitable institutions are registered charitable organizations in other countries. Before providing funds to the partners, Helping Hand completes extensive background check of these institutes.

Helping Hand is a non-political, non-profit charity organization, devoted to global humanitarian relief and development. Helping Hand's mission is to strengthen the bond of humanity by responding to human sufferings in disasters anywhere in the world. It provides emergency relief, rehabilitation and developmental programs in the areas effected by natural or man made disasters with special focus on needy people in Africa & Asia.

#### **Note -2**

##### **Income Taxes**

Helping Hand is publicly supported organization and is exempt from income taxes under section 501(c) (3) of the Internal Revenue Code and comparable state law.

**Note -3****Unrestricted Net Assets**

During the year Helping Hand received around 91% of its total contributions from ICNA Relief. Since donors have not stipulated any restrictions on the donations, no part of the donation has been reported as restricted or temporary restricted net assets. Also, since no commitments are made to the recipients, unspent money is not required to be recorded as liability.

**Note -4****Major recipient of donation**

Help In Need is a charity organization registered under the Pakistan Laws. During the year Helping Hand USA contributed \$ 507,000 to Helping In Need, Islamabad for various services of the total contribution of \$ 816,000, during the year 2005.

**Note -5****Related Party Transaction**

Helping Hand and ICNA Relief were related parties in 2005. During the year ICNA donated \$2,276,730.to Helping Hand.
